• <u>Member Forum</u> – Roberta Ringstrom – President

President Ringstrom moved this portion of the Agenda to enable members present to ask questions throughout the meeting.

• <u>New Business</u> – Roberta Ringstrom – President

- a. 2012 Waldo Canyon Wildfire.
- b. Post Waldo Canyon Wildfire Issues:
 - Arbors Association Flood Insurance. President Ringstrom explained that one of the resulting issues from the Waldo Canyon Wildfire is flood concerns. She explained that the cost quote obtained from the National Insurance Program (FEMA) after the Waldo Canyon Wildfire for the Arbors is \$68,000 per year. She explained that the Board has been and will continue to investigate preventative and other measures to help avoid flood damages to the Arbors. She explained that the Association has already obtained 450-500 free sandbags that are being stored at no charge by TJP Enterprises. TJP Enterprises is also on 24/7 call in the event of potential flooding to put out sandbags along the Douglas Creek Storm Ditch that runs along the west side of the Arbors property, as well as in other locations around the property.

President Ringstrom also explained that it is up to the homeowners to investigate and determine if they want to purchase flood insurance for inside their condo units.

- New Building Codes. President Ringstrom explained that possible new building codes being proposed by the City of Colorado Springs Fire Department. She explained that the Association will notify the homeowners of any changes in building codes when and if approved by the Colorado Springs City Council.
- c. Homeowner Flood Insurance Questions & Answers Bob Monroe-American Family Insurance. Bob Monroe gave a brief presentation on homeowner flood insurance. He stated that the cost is typically \$125 - \$150 per year for the condo units at the Arbors.
- d. Homeowner (HOA) Insurance Questions & Answers Bob Monroe American Family Insurance. Bob Monroe gave a brief presentation on homeowner HOA insurance.
- e. Presentation of 2013 Budget & Annual Assessments (Dues) Roberta Ringstrom, President.
- President Ringstrom reviewed the 2013 Budget and six (6%) percent Due increase that were mailed to the 140 homeowners and approved by the Board at the October 16, 2012 Regular Board Meeting. There were many questions from the members.
